



The relative strengths and weaknesses of Herner Gesellschaft für Wohnungsbau mbH HGW are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Herner Gesellschaft für Wohnungsbau mbH HGW compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Herner Gesellschaft für Wohnungsbau mbH HGW is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 620% points.

The company's Economic Capital Ratio, given in the ranking table, is 52%, being 105% points below the market average of 156%.
