



The relative strengths and weaknesses of WBV Wohnbau Betreuungs Verwaltungs GmbH Salzgitter are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WBV Wohnbau Betreuungs Verwaltungs GmbH Salzgitter compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 26% points. The greatest weakness of WBV Wohnbau Betreuungs Verwaltungs GmbH Salzgitter is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 765% points.

The company's Economic Capital Ratio, given in the ranking table, is 26%, being 130% points below the market average of 156%.
