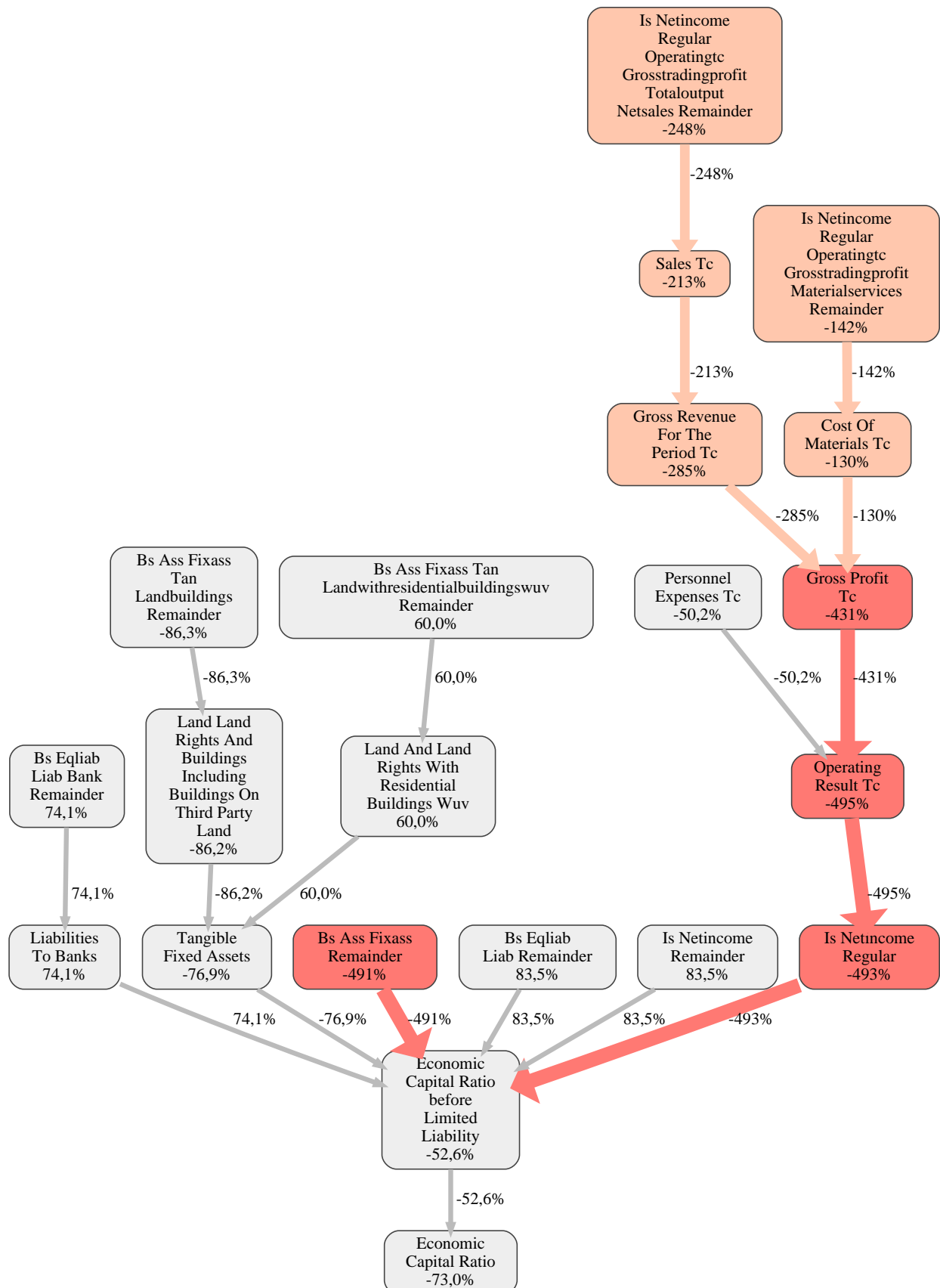

The relative strengths and weaknesses of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter is the variable Operating Result Tc, reducing the Economic Capital Ratio by 495% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 73% points below the market average of 156%.
