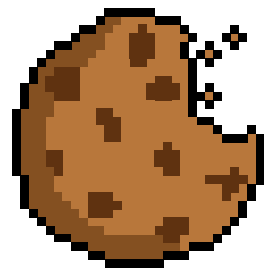
The greatest strength of Gesobau Wohnen GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 36% points. The greatest weakness of Gesobau Wohnen GmbH Co KG is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 674% points.

The company's Economic Capital Ratio, given in the ranking table, is 36%, being 120% points below the market average of 156%.

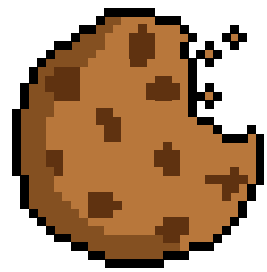
