

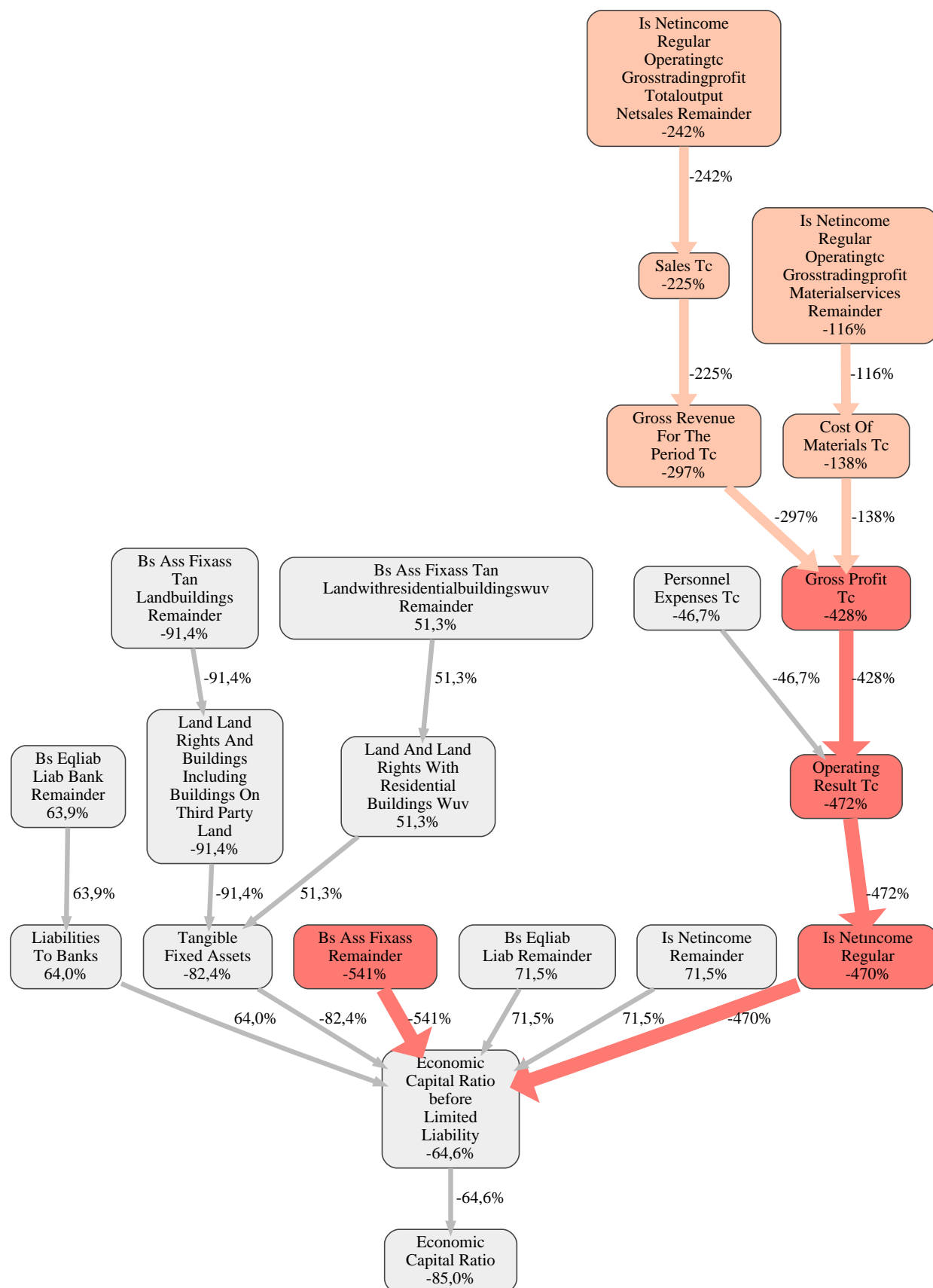

The relative strengths and weaknesses of WBF Wohnungsbaugesellschaft Friedrichshain mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WBF Wohnungsbaugesellschaft Friedrichshain mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 71% points. The greatest weakness of WBF Wohnungsbaugesellschaft Friedrichshain mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 541% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 85% points below the market average of 156%.
