



The relative strengths and weaknesses of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 127% points. The greatest weakness of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 482% points.

The company's Economic Capital Ratio, given in the ranking table, is 127%, being 30% points below the market average of 156%.
