

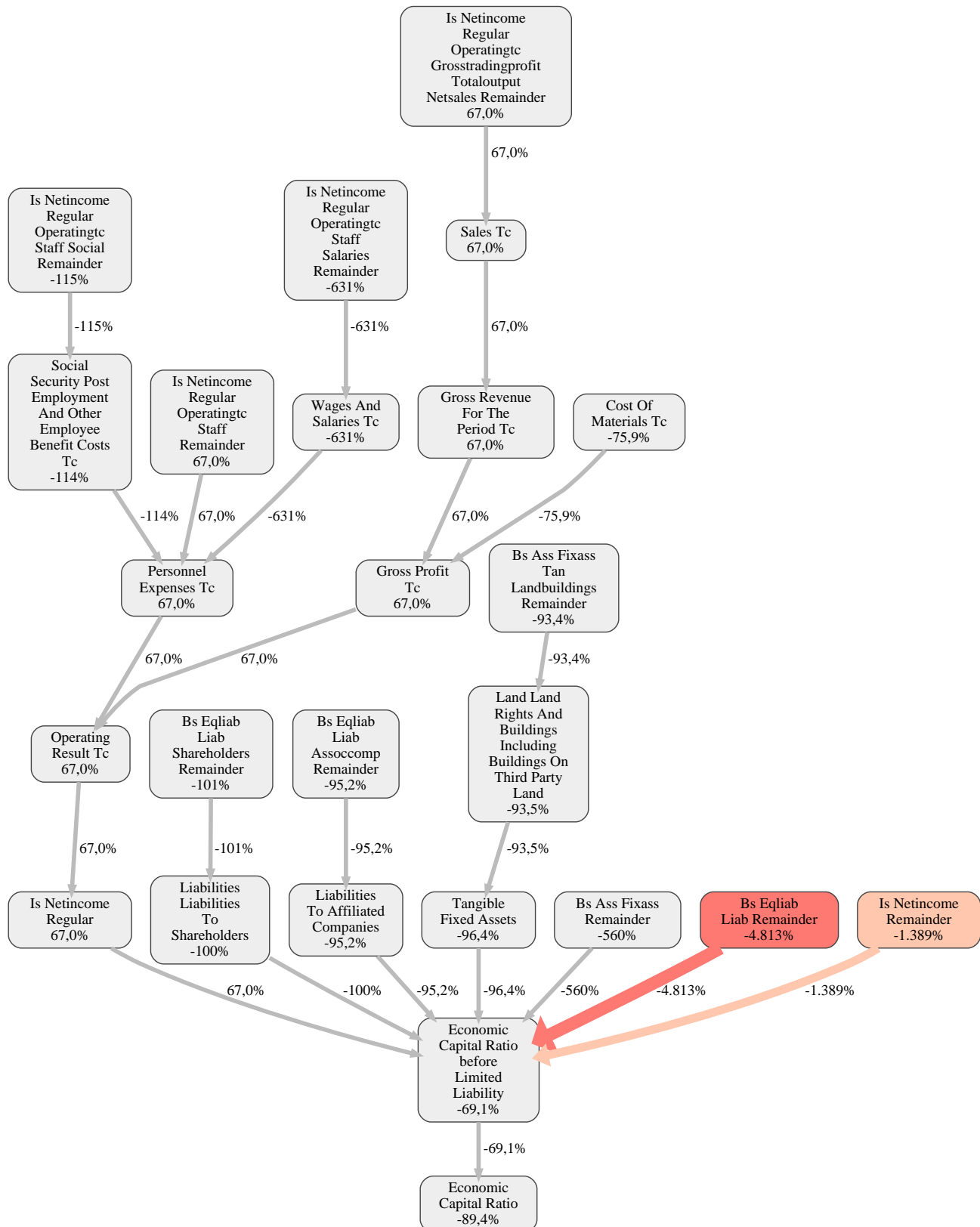

The relative strengths and weaknesses of Degewo Gebäudeservice GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Degewo Gebäudeservice GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Degewo Gebäudeservice GmbH is the variable Bs Eqliab Liab Remainder, reducing the Economic Capital Ratio by 4.813% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 89% points below the market average of 156%.
