



The relative strengths and weaknesses of Auer Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Auer Wohnungsbaugesellschaft mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Auer Wohnungsbaugesellschaft mbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 517% points.

The company's Economic Capital Ratio, given in the ranking table, is 140%, being 17% points below the market average of 156%.
