



The relative strengths and weaknesses of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 22% points. The greatest weakness of Röhrsdorfer Wohnungsbauförderungsgesellschaft mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 799% points.

The company's Economic Capital Ratio, given in the ranking table, is 22%, being 135% points below the market average of 156%.
