



The relative strengths and weaknesses of Wohnungsbaugesellschaft Lößnitz mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Lößnitz mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 135% points. The greatest weakness of Wohnungsbaugesellschaft Lößnitz mbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 517% points.

The company's Economic Capital Ratio, given in the ranking table, is 135%, being 22% points below the market average of 156%.
