



The relative strengths and weaknesses of Wohnungsbaugesellschaft Kreis Steinfurt mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Kreis Steinfurt mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Wohnungsbaugesellschaft Kreis Steinfurt mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 516% points.

The company's Economic Capital Ratio, given in the ranking table, is 78%, being 79% points below the market average of 156%.
