



The relative strengths and weaknesses of Stadtbau GmbH Deggendorf are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stadtbau GmbH Deggendorf compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Stadtbau GmbH Deggendorf is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 504% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 73% points below the market average of 156%.
