



The relative strengths and weaknesses of Kommunale Immobilien Dresden GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kommunale Immobilien Dresden GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 143% points. The greatest weakness of Kommunale Immobilien Dresden GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 484% points.

The company's Economic Capital Ratio, given in the ranking table, is 143%, being 13% points below the market average of 156%.
