



The relative strengths and weaknesses of Müncheberger Wohnungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Müncheberger Wohnungsgesellschaft mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 46% points. The greatest weakness of Müncheberger Wohnungsgesellschaft mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 641% points.

The company's Economic Capital Ratio, given in the ranking table, is 46%, being 111% points below the market average of 156%.
