



The relative strengths and weaknesses of Sewoba GmbH Seelower Wohnungsbaugesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sewoba GmbH Seelower Wohnungsbaugesellschaft compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Sewoba GmbH Seelower Wohnungsbaugesellschaft is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 509% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 77% points below the market average of 156%.
