



The relative strengths and weaknesses of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 505% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 76% points below the market average of 156%.
