



The relative strengths and weaknesses of Städtische Wohnbaugesellschaft Lörrach mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Städtische Wohnbaugesellschaft Lörrach mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 234% points. The greatest weakness of Städtische Wohnbaugesellschaft Lörrach mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 475% points.

The company's Economic Capital Ratio, given in the ranking table, is 234%, being 77% points above the market average of 156%.
