



The relative strengths and weaknesses of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 54% points. The greatest weakness of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz is the variable Operating Result Tc, reducing the Economic Capital Ratio by 465% points.

The company's Economic Capital Ratio, given in the ranking table, is 54%, being 103% points below the market average of 156%.
