



The relative strengths and weaknesses of Bad Nauheimer Wohnungsbaugesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bad Nauheimer Wohnungsbaugesellschaft mit Beschränkter Haftung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 55% points. The greatest weakness of Bad Nauheimer Wohnungsbaugesellschaft mit Beschränkter Haftung is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 608% points.

The company's Economic Capital Ratio, given in the ranking table, is 55%, being 102% points below the market average of 156%.
