The greatest strength of Wohnungsbaugesellschaft der Stadt Langenzenn Gesellschaft mit Beschränkter Haftung GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Wohnungsbaugesellschaft der Stadt Langenzenn Gesellschaft mit Beschränkter Haftung GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 509% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 63% points below the market average of 156%.
