



The relative strengths and weaknesses of WGS Wohnungsgesellschaft Sömmerda mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WGS Wohnungsgesellschaft Sömmerda mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 109% points. The greatest weakness of WGS Wohnungsgesellschaft Sömmerda mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 450% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 47% points below the market average of 156%.
