

The relative strengths and weaknesses of Wohnungsbau GmbH der Stadt Schmalkalden are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau GmbH der Stadt Schmalkalden compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 96% points. The greatest weakness of Wohnungsbau GmbH der Stadt Schmalkalden is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 489% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 60% points below the market average of 156%.
