The relative strengths and weaknesses of Sozialbau Kempten Wohnungs und Städtebaugesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sozialbau Kempten Wohnungs und Städtebaugesellschaft mit Beschränkter Haftung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Sozialbau Kempten Wohnungs und Städtebaugesellschaft mit Beschränkter Haftung is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 480% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 70% points below the market average of 156%.
