



The relative strengths and weaknesses of Wohnbau Mainz Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau Mainz Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 165% points. The greatest weakness of Wohnbau Mainz Gesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 485% points.

The company's Economic Capital Ratio, given in the ranking table, is 165%, being 8,8% points above the market average of 156%.
