



The relative strengths and weaknesses of Wohnungsbau GmbH Worms are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau GmbH Worms compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Wohnungsbau GmbH Worms is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 526% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 81% points below the market average of 156%.
