



The relative strengths and weaknesses of Gemeinnützige Wohnungsbau GmbH Marburg Lahn are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gemeinnützige Wohnungsbau GmbH Marburg Lahn compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Gemeinnützige Wohnungsbau GmbH Marburg Lahn is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 583% points.

The company's Economic Capital Ratio, given in the ranking table, is 61%, being 95% points below the market average of 156%.
