



The relative strengths and weaknesses of Wohnbau GmbH Prenzlau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau GmbH Prenzlau compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 64% points. The greatest weakness of Wohnbau GmbH Prenzlau is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 574% points.

The company's Economic Capital Ratio, given in the ranking table, is 64%, being 93% points below the market average of 156%.
