



The relative strengths and weaknesses of Gewobau der Stadt Schwabach GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gewobau der Stadt Schwabach GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 157% points. The greatest weakness of Gewobau der Stadt Schwabach GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 486% points.

The company's Economic Capital Ratio, given in the ranking table, is 157%, being 0,38% points above the market average of 156%.
