

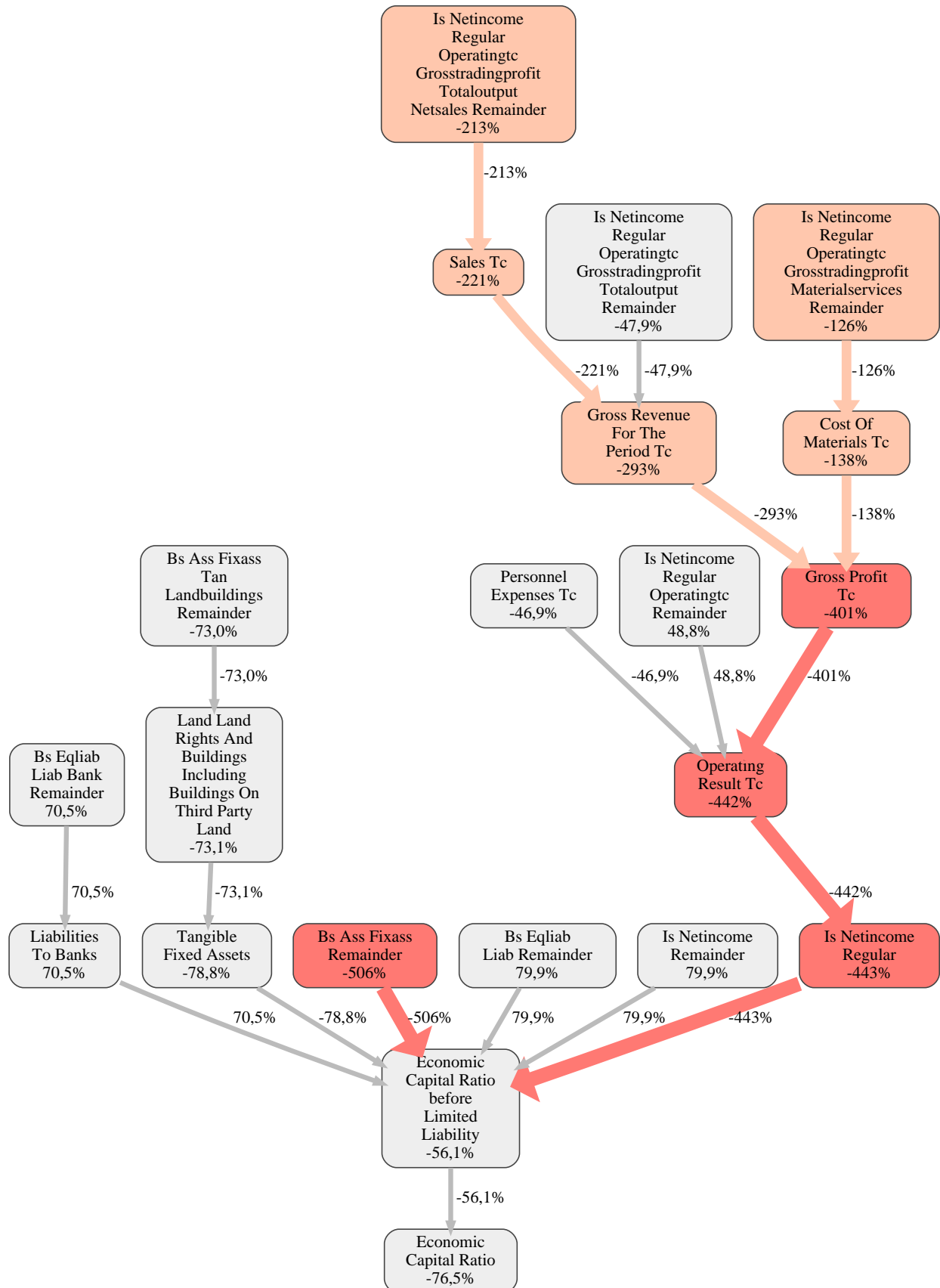

The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mbH Ketzin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mbH Ketzin compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mbH Ketzin is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 506% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 77% points below the market average of 156%.
