The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mit Beschränkter Haftung Dahme Mark are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mit Beschränkter Haftung Dahme Mark compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mit Beschränkter Haftung Dahme Mark is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 586% points.

The company's Economic Capital Ratio, given in the ranking table, is 61%, being 96% points below the market average of 156%.
