



The relative strengths and weaknesses of Wohnungsbaugesellschaft Ziesar m b H are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Ziesar m b H compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Wohnungsbaugesellschaft Ziesar m b H is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 588% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 96% points below the market average of 156%.
