



The relative strengths and weaknesses of Wohnungsgesellschaft Recklinghausen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsgesellschaft Recklinghausen mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 50% points. The greatest weakness of Wohnungsgesellschaft Recklinghausen mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 627% points.

The company's Economic Capital Ratio, given in the ranking table, is 50%, being 107% points below the market average of 156%.
