



The relative strengths and weaknesses of Bundesbahn Wohnungsbaugesellschaft Regensburg mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bundesbahn Wohnungsbaugesellschaft Regensburg mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 113% points. The greatest weakness of Bundesbahn Wohnungsbaugesellschaft Regensburg mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 398% points.

The company's Economic Capital Ratio, given in the ranking table, is 113%, being 44% points below the market average of 156%.
