

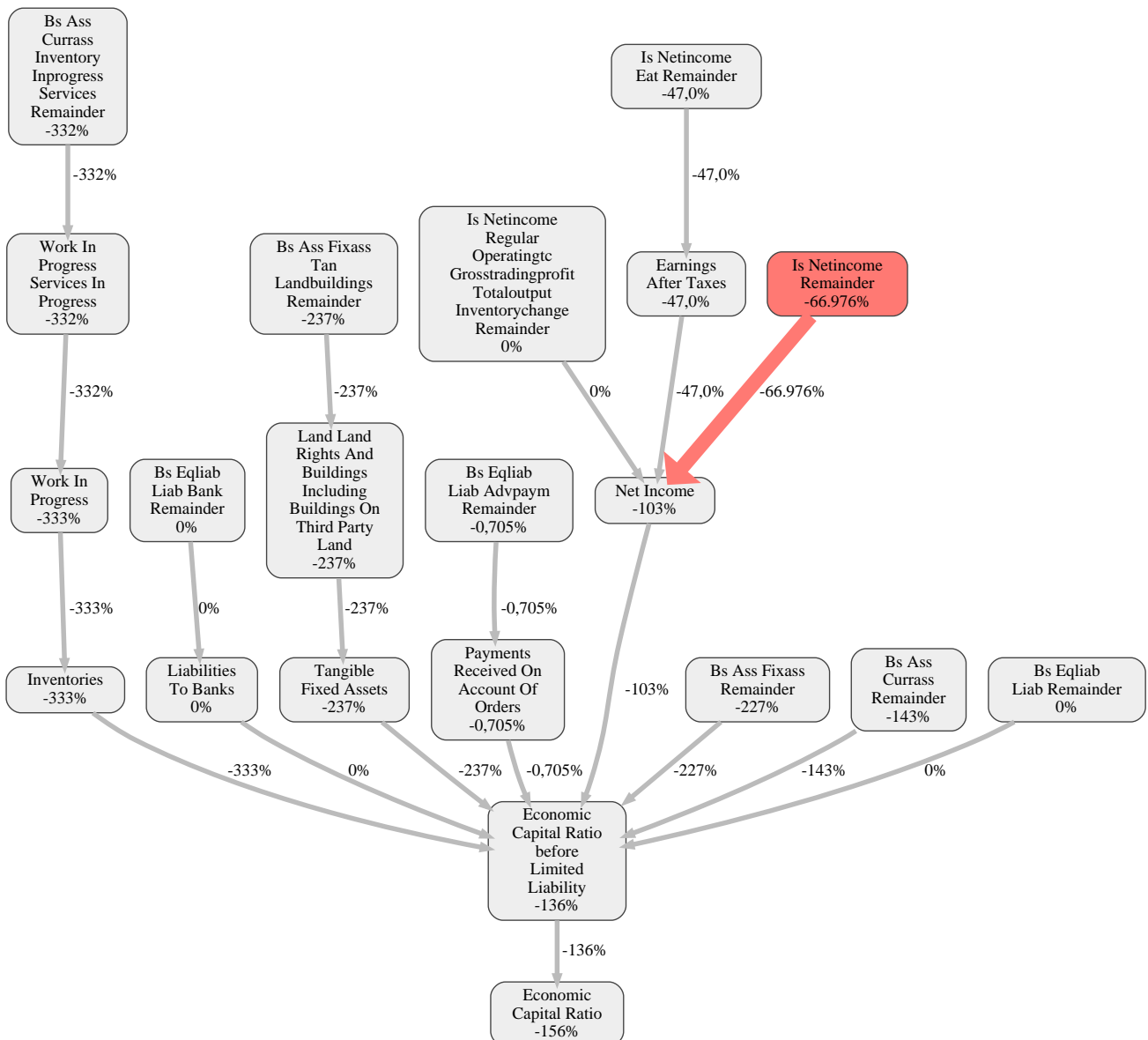

The greatest weakness of WGS Wohnungsgesellschaft Schwerin mbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 66.976% points.

The company's Economic Capital Ratio, given in the ranking table, is 0%, being 156% points below the market average of 156%.
