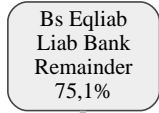

The relative strengths and weaknesses of BAL Stadtentwicklungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BAL Stadtentwicklungsgesellschaft mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of BAL Stadtentwicklungsgesellschaft mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 485% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 71% points below the market average of 156%.
