



The relative strengths and weaknesses of Wohnungs und Baugesellschaft Wolfen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungs und Baugesellschaft Wolfen mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Wohnungs und Baugesellschaft Wolfen mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 493% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 73% points below the market average of 156%.
