



The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald is the variable Operating Result Tc, reducing the Economic Capital Ratio by 469% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 64% points below the market average of 156%.
