



The relative strengths and weaknesses of Städtische Wohnungsbaugesellschaft Friedrichshafen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Städtische Wohnungsbaugesellschaft Friedrichshafen mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Städtische Wohnungsbaugesellschaft Friedrichshafen mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 565% points.

The company's Economic Capital Ratio, given in the ranking table, is 66%, being 91% points below the market average of 156%.
