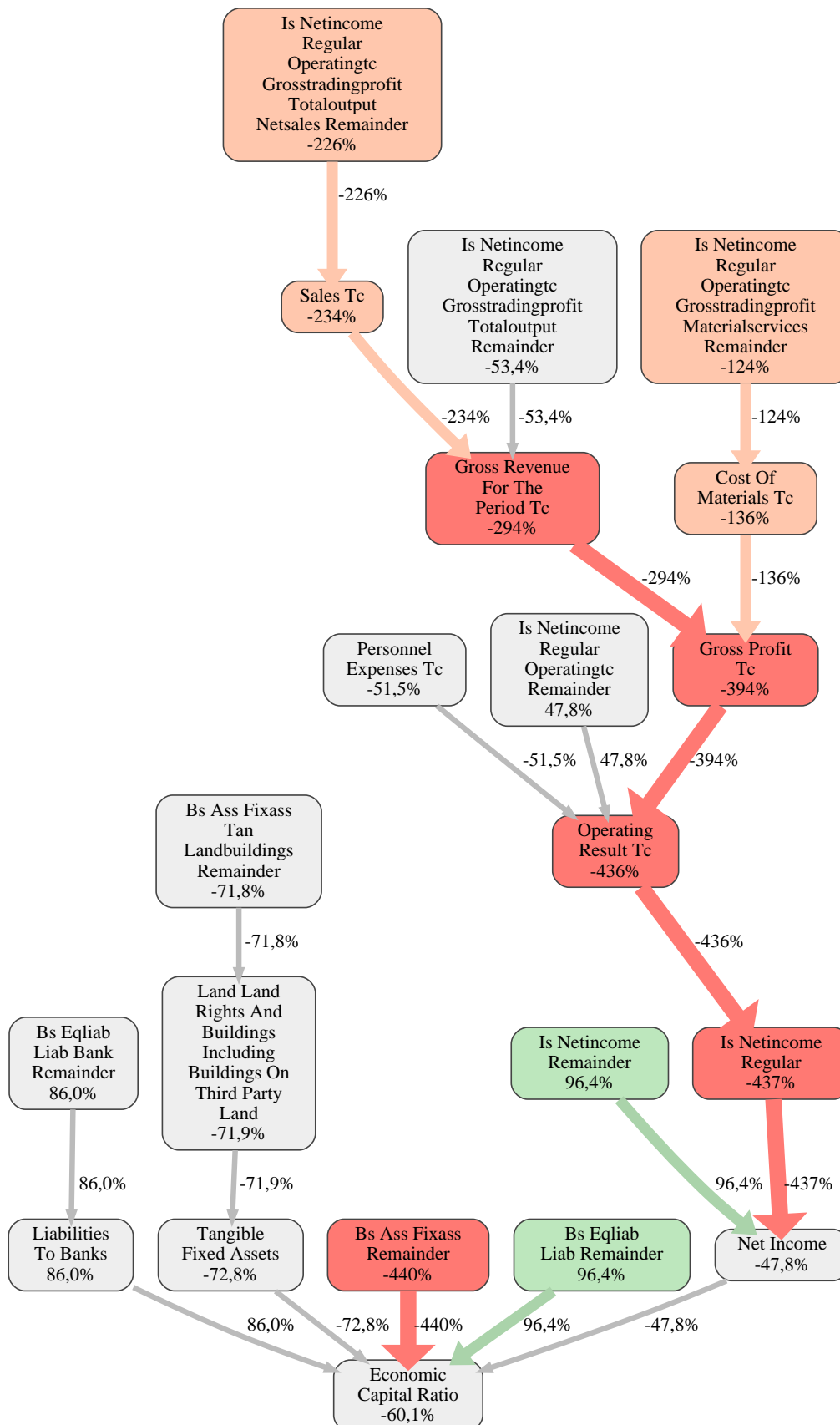

The relative strengths and weaknesses of Wohnbau GmbH Göppingen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau GmbH Göppingen compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 96% points. The greatest weakness of Wohnbau GmbH Göppingen is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 440% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 60% points below the market average of 156%.
