



## Gemeinnützige Eisenbahn Wohnungsbau Gesellschaft mit Beschränkter Haftung Wuppertal

The relative strengths and weaknesses of Gemeinnützige Eisenbahn Wohnungsbau Gesellschaft mit Beschränkter Haftung Wuppertal are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gemeinnützige Eisenbahn Wohnungsbau Gesellschaft mit Beschränkter Haftung Wuppertal compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 39% points. The greatest weakness of Gemeinnützige Eisenbahn Wohnungsbau Gesellschaft mit Beschränkter Haftung Wuppertal is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 665% points.

The company's Economic Capital Ratio, given in the ranking table, is 39%, being 118% points below the market average of 156%.
