



The relative strengths and weaknesses of Stadtbau Würzburg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stadtbau Würzburg GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 213% points. The greatest weakness of Stadtbau Würzburg GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 479% points.

The company's Economic Capital Ratio, given in the ranking table, is 213%, being 57% points above the market average of 156%.
