



The relative strengths and weaknesses of WSG Wohnungsbau und Siedlungsgesellschaft für den Kreis Coesfeld mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WSG Wohnungsbau und Siedlungsgesellschaft für den Kreis Coesfeld mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 21% points. The greatest weakness of WSG Wohnungsbau und Siedlungsgesellschaft für den Kreis Coesfeld mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 800% points.

The company's Economic Capital Ratio, given in the ranking table, is 21%, being 135% points below the market average of 156%.
