



The relative strengths and weaknesses of Beeskower Wohnungsbau und Verwaltungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Beeskower Wohnungsbau und Verwaltungsgesellschaft mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Beeskower Wohnungsbau und Verwaltungsgesellschaft mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 481% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 65% points below the market average of 156%.
