



The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 602% points.

The company's Economic Capital Ratio, given in the ranking table, is 56%, being 100% points below the market average of 156%.
