

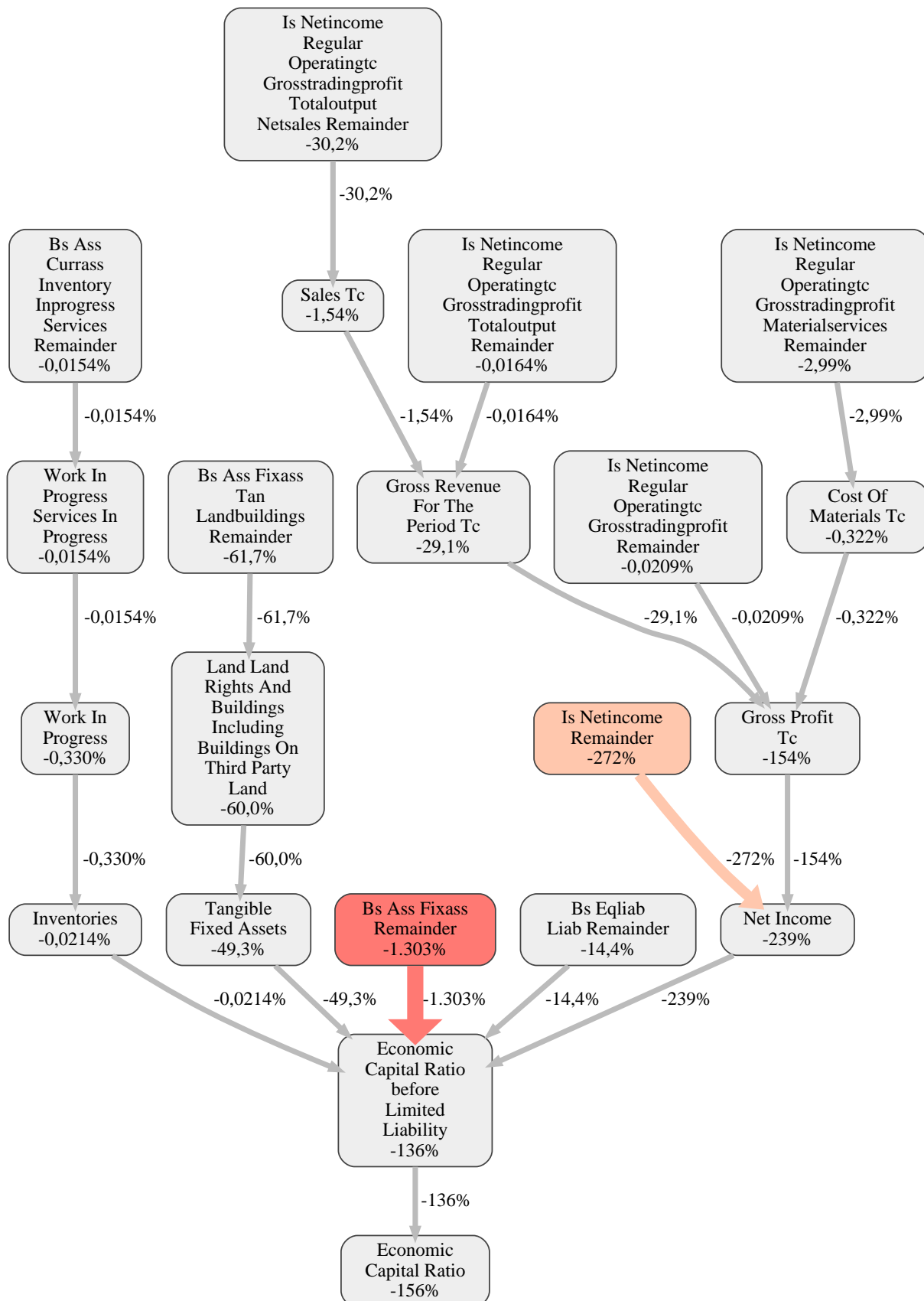

The greatest strength of wb Service GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Salaries Remainder, increasing the Economic Capital Ratio by 0,00012% points. The greatest weakness of wb Service GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 1.303% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,00012%, being 156% points below the market average of 156%.
