



The relative strengths and weaknesses of IWS Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of IWS Bau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 146% points. The greatest weakness of IWS Bau GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 518% points.

The company's Economic Capital Ratio, given in the ranking table, is 146%, being 11% points below the market average of 156%.
