





The relative strengths and weaknesses of Baugeschäft Ritter Homann Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Baugeschäft Ritter Homann Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Baugeschäft Ritter Homann Gesellschaft mit Beschränkter Haftung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 506% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 70% points below the market average of 156%.
