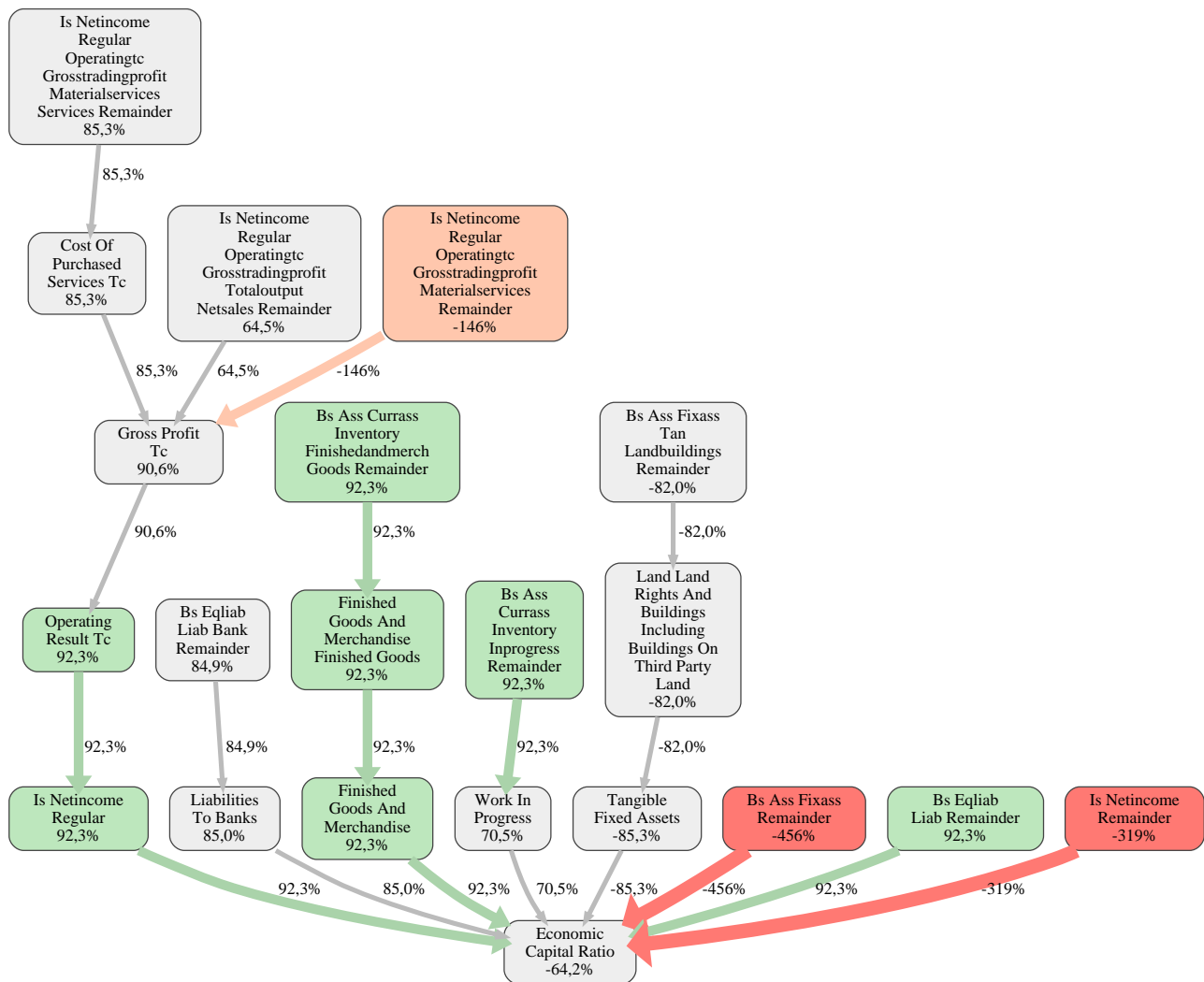

The greatest strength of F K HORN GmbH Co KG Bauunternehmung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of F K HORN GmbH Co KG Bauunternehmung is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 456% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 64% points below the market average of 156%.
