

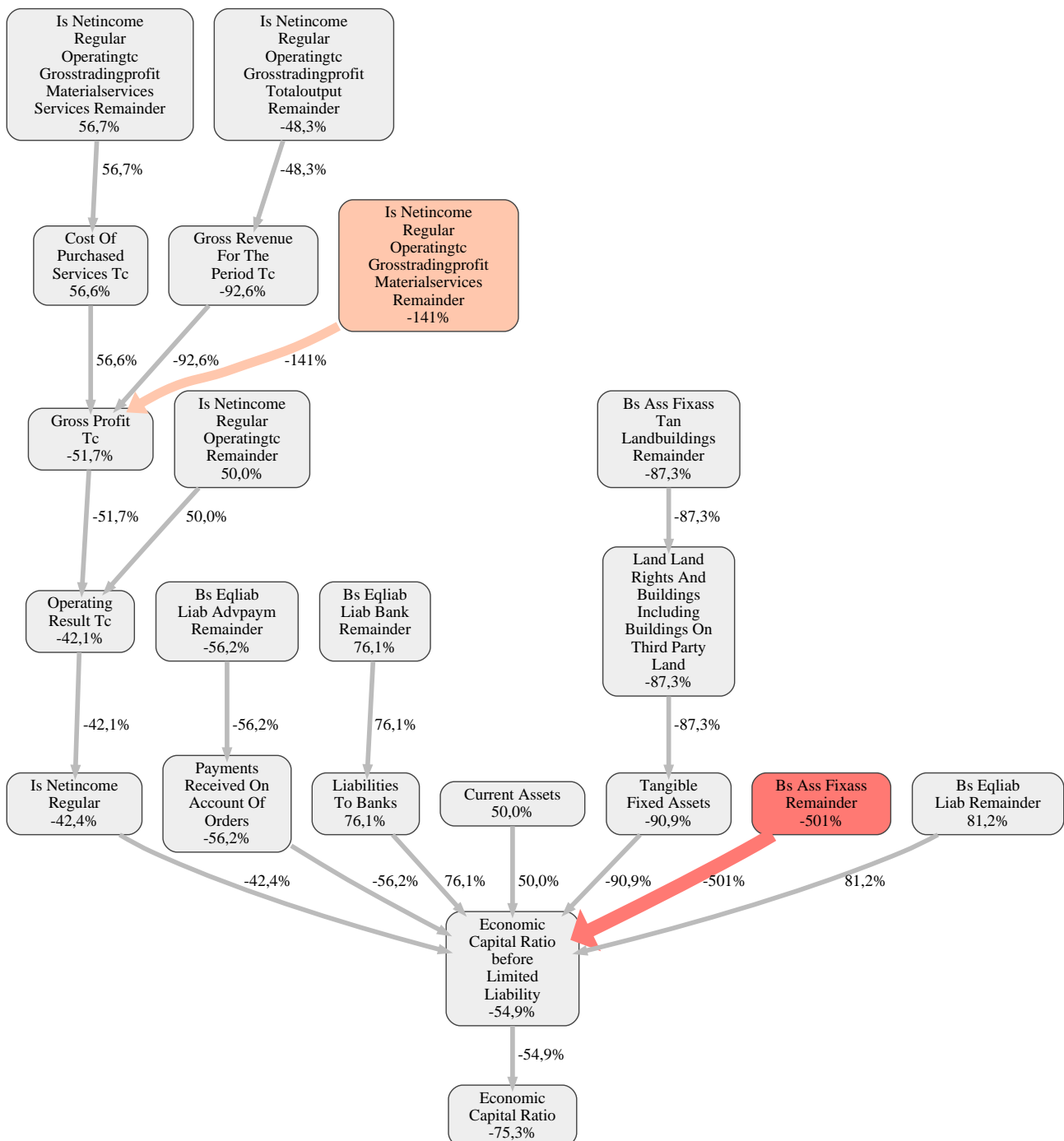

The relative strengths and weaknesses of Johann Feldbauer Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Johann Feldbauer Bau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Johann Feldbauer Bau GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 501% points.

The company's Economic Capital Ratio, given in the ranking table, is 81%, being 75% points below the market average of 156%.
