



The relative strengths and weaknesses of Bremer Leipzig GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer Leipzig GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 171% points. The greatest weakness of Bremer Leipzig GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 1.376% points.

The company's Economic Capital Ratio, given in the ranking table, is 171%, being 15% points above the market average of 156%.
